^{*} MaineHousing administers vouchers in all areas of the state that are not served by a local public housing authority, through program agents covering such areas in each of Maine's sixteen counties. Each county program maintains its own voucher waiting list. The waiting lists in Androscoggin, York, Cumberland and Oxford counties were all closed on January 4, 2010; the Penobscot County list was closed in the spring of 2007. MaineHousing's waiting lists in all other counties are currently open.
